*Mayor Nikki Morgan called the meeting to order at 5:30 pm and led the flag salute.

Approval of June 22, 2021 Agenda

Councilor Beers made a motion to approve the June 22, 2021 agenda. Councilor Miller seconded the motion. All ayes, motion carried.

Approval of Minutes from May 25, 2021 and June 8, 2021

Councilor Beers made a motion to approve the May 25, 2021, and June 8, 2021, minutes. Councilor Quick seconded the motion. All ayes, motion carried.

Accounts Payable for June 8, 2021 June 22, 2021 and June 22, 2021

Councilor Beers made a motion to approve the Accounts Payable for June 8, 2021 in the amount of \$16,987.01, June 22, 2021 in the amount of \$966,282.73 and June 22, 2021 in the amount of \$1,007.57. Councilor Quick seconded the motion. All ayes, motion carried.

Public Comment Non-Agenda Items (Speaking time limits may apply)

Chris Wiseman – Addressed the Council about SASO (Second Amendment Sanctuary Ordinance). He stated it was passed in the County and would like to know if the City will adopt a similar ordinance so that the City does not use its resources to impose on the 2nd Amendment rights of the citizens of Hines, until such time as it goes to ballot to be voted

on by the people. Several counties in the state have adopted the ordinance. SB 554 takes effect 91 days after the end of the current senate session. There is a referendum in the works to repeal this bill. Councilor Quick asked why we don't wait for the state vote? Mr. Wiseman explained that currently SB 554 will go into effect and a referendum has not been introduced yet. He said currently it is very hard to voice your opinion in Salem right now as many government offices are closed to the public.

Daniel Crowe – With State offices closed to the public, passing this ordinance is a way for the City of Hines to show the State government that SB 554 is not in line with the values of the residents of Hines. He said SB 554 is also against Section 27 of the Oregon Bill of Rights. He also stated that a clause in SB 554 says that if a gun is stolen and used in the commission of a crime, the gun owner is civilly responsible for that crime. "This takes reasonableness out of the law".

*City Council Meeting was temporarily adjourned to convene the Budget Hearing at 6:46pm.

Resolution 2301 is a resolution of the City of Hines to adopt the 2021/2022 Budget in the total amount of \$6,688,788 as read. Councilor Beers made a motion to approve Resolution No. 2301 as read. Councilor Shepherd seconded the motion. All ayes, the motion carried.

Resolution 2302 – Loss Prevention Program Annual Evaluation – Administrator Letham read Resolution No. 2302 in its entirety. A loss control/safety committee has been created for both City Hall and the Fire Department. This program is evaluated annually. Councilor Quick made a motion to approve Resolution No. 2302 as read. Councilor Beers seconded the motion. All ayes, the motion carried.

Resolution 2303 – A Resolution Declaring the City's Election to Receive State Revenues – Administrator Letham read Resolution No. 2303 in its entirety. Resolution 2303 is a resolution of the City of Hines to receive State revenues for fiscal year 2021/2022. Councilor Beers made a motion to approve Resolution No. 2303 as read. Councilor Miller seconded the motion. All ayes, the motion carried.

Resolution 2304 – A Resolution Extending Workers' Compensation Coverage to Volunteers for the City of Hines – Administrator Letham read Resolution No. 2304 in its entirety. Resolution No. 2304 is a resolution to provide Workers' Compensation to city volunteer classes listed in this resolution. Councilor Beers made a motion to approve Resolution No. 2304 as read. Councilor York seconded the motion. All ayes, the motion carried.

Resolution 2305 – A Resolution Transferring Monies Between Objects of Expenditures – Administrator Letham read Resolution No. 2305 in its entirety. Resolution No. 2305 transfers monies between objects of expenditure for the 2021/2022 budget year. Councilor Quick motioned to approve Resolution No. 2305 as read. Councilor Beers seconded the motion. All ayes, the motion carried.

Resolution 2300 – A Resolution Repealing Resolution No. 2268, and Repealing Resolution No. 2297, and All Preceding Resolutions or Ordinances Pertaining to the Setting of Water Meter Rates and Volume Charges, and Authorizing Collection of Such Funds – Administrator Letham read Resolution No. 2300 in its entirety. Resolution No. 2300 allows the City to begin charging water usage effective July 1, 2021 and will charge usage based upon gallons of water used rather than cubic feet. Councilor Quick made a motion to approve Resolution No. 2300 as read. Councilor Beers seconded the motion. All ayes, the motion carried.

Resolution 2306 – A Resolution of the City of Hines Oregon, Accepting Certain Identified Unanticipated Revenues, in the Form of Donations for City Park Improvement to be Added to the General Fund, and Authorizing its Expenditure – Administrator Letham read Resolution No. 2306 in its entirety. Resolution No. 2306 accepts a donation from Streamline Consulting, LLC in the amount of \$3,000.00 for Park improvements. Councilor Beers made a motion to approve Resolution No. 2306 as read. Councilor York seconded the motion. All ayes, the motion carried.

Resolution 2307 – A Resolution of the City of Hines, Oregon, Accepting Certain Identified Unanticipated Revenues, in the Form of Donations for the Hines Fire Department to be Added to the General Fund, and Authorizing its Expenditure – Administrator Letham read Resolution No. 2307 in its entirety. Resolution No. 2307 accepts a donation from New Sun Energy, LLC in the amount of \$5,000.00 for the Fire Department. Councilor Quick made a motion to approve Resolution No. 2307 as read. Councilors Shepherd/Beers seconded the motion. All ayes, the motion carried.

Planning: Banton Variance Request - Administrator Letham read the Findings and Decision from the Hines Planning Commission for a variance for Kris and Christina Banton at 217 Jones Ave. The Banton's are requesting a shop of 1,440 sf and a roof peak of 21'. The Planning Commission approved recommending that the City Council approve the Banton's request. Councilor Quick asked Mr. Banton why such a high roof peak? Mr. Banton said the engineers said for snow load that was the height they needed. Councilor Quick also recognized that a neighbor was against the bigger shop. Councilor Beers said that 144 sf is not much bigger than what they had. Councilors discussed whether current rules need to be changed. Mayor Morgan stated that the previous shop was built by the previous owner who wanted a bigger shop but didn't get it. Administrator Letham discussed that the original intent of the mandated size was that some lots are rather small and that the oversized shops begin crowding neighborhoods. Also, the bigger the shop, the more a shop can be used for, and it could lead to industrial work in residential neighborhoods. Councilor York asked if this sets precedence? Mayor Morgan said that each variance is supposed to be based on its own merit. Councilor Quick said she thinks the original size is more than adequate. Councilor Miller sees no issue with the taller shop. Councilor York said in general she is against the bigger shop, except that the Banton's are in an area that could handle a bigger shop. Councilor Shepherd made a motion to approve the variance as recommended by the Planning Commission. Councilor Miller seconded the motion. 4 ayes, 1 Nay (Quick)

TLT Opportunity: Plectrum Music Co. "Beer & Brats Music Festival" — Daniel Porter owner of Plectrum Music Co. and chairs the Harney County Small Business Committee. The Committee has been working on how to bring people to our community. He lived in Boise, ID and while there he organized music festivals. His idea was to host a music festival with his band. More people have become involved. The Central Hotel will bring food and supply a beer garden. Additional food vendors have committed to participating. Beverage vendors are participating. Activities for kids and families. The City of Burns has agreed to close Washington St. to through traffic between Broadway and Alvord. This year is local bands, food, merchandise vendors, and some bands from out of the area. The plan is to make this an annual event. Lots of energy gathering. He's already received confirmation on some donations. He was asked how much he was charging for the event. He said this year he is not charging anything. He is asking for donations to be able to get this event up and running. Andrea Letham spoke for Small Business Development Center in support of Dan. She said that Dan has been working with businesses in Hines to get

them involved so that it is not a "City of Burns" event, but a community event involving both cities. Councilor Beers asked if Dan is still soliciting for donations from others and was told yes. Discussion between Council members as to how much to approve. Councilor Quick made a motion to donate \$3,059.00 from TLT funds to the Beer & Brats Music Festival. Councilor York seconded the motion. 3 Ayes, 2 Nays, motion carried.

TLT Opportunity: Kiwanis Club 4th of July Fireworks – Councilor Quick made a motion to donate \$939.00 from TLT funds to the Kiwanis 4th of July Fireworks show. Councilor Beers seconded the motion. All ayes, motion carried.

Livestock Permit: Bamford/Kokesh – Chickens – Councilor Miller made a motion to approve the livestock permit for Bamford/Kokesh allowing chickens. Councilor Shepherd seconded the motion. All ayes, motion carried.

Resolution 2308 – A Resolution for a Budgeted Transfer Between Funds – Administrator Letham read Resolution No. 2308 in its entirety. Transfer of \$26,200.00 from the Sewer line item to Capital Projects/Sewer, setting aside funds to pay for future investment in the sewer fund. Councilor Shepherd made a motion to approve Resolution No. 2308 as read. Councilor Beers seconded the motion. All ayes, the motion carried.

Business License: TESLA Charging Station – Councilor Beers made a motion to approve the business license for Tesla, Inc. Councilor York seconded the motion. All ayes, motion carried.

Public Comment Period (Speaking time limits may apply):

Andrea Letham Small Business Development Center (SBDC) – Ms. Letham asked what the Economic Development grant is, and what are the rules? Mayor Morgan said it can be used for a multitude of things. It cannot be used for things like inventory. It has been used for beautification, structural improvements, etc. Ms. Letham thanked the City Council for their support of local business.

Mayor and Council Comments

Councilor York – She has been approached by residents to ask if the City would consider installing speed bumps to slow down traffic.

Councilor Shepherd – She has been approached by multiple residents thanking the City for the mosquito control.

Councilor Quick – She agrees with Councilor Shepherd about the mosquito control. She was at the Skate Park and found a sign with the park name. She asked if the City could get the bushes trimmed back so the sign is visible. She also thanked administrator Letham for his work on the 2021/2022 budget.

Councilor Beers – Thanked Administrator Letham and thanks for the mosquito control. He also suggested the Councilors research for themselves about the Second Amendment Sanctuary Ordinance.

Councilor Miller – He really likes the idea that Dan Porter presented for the music festival. He asked if Boomer Inselman still have the money that was given by the City and was told yes. Administrator Letham will speak to him to find out whether or not he is going forward with the event that he had requested the donation for.

Mayor Morgan – We need more bike stands access. She has found one that is fairly inexpensive using recycled tires. Suggested asking Les Schwab if they will donate old tires and having Public Works put them together and install them in the Parks.

Councilor York – Was talking to a young man in the skateboard community who travels between Bend and Boise, and he told her that the skateboard community is starting to talk about our park and the improvements that have been made. She said she would talk to him again and gather his suggestions on other improvements. She will pass on ideas to Councilor Quick.

Councilor Shepherd: Asked if we could get a crosswalk painted between the north and south parks. Administrator Letham made a note to get a sidewalk painted.

Next Council Meeting is scheduled for July 13, 2021, at 6:30pm.

There being no further business, Councilor Beers made a motion to adjourn the meeting. Councilor Miller seconded the motion. All ayes, the motion carried. Meeting adjourned at 8:32pm.





THE DULY-ELECTED COUNTY COURT OF HARNEY COUNTY OREGON FIND AND DECLARE:

WHEREAS, Acting through the United States Constitution, the people created government to be their agent in the exercise of a few defined powers, while reserving the citizen's right to decide on matters, which concern their lives, liberties, and properties in the ordinary course of affairs;

WHEREAS, The Second Amendment to the Constitution of the United States of America states, "A well-regulated Militia being necessary to the security of a free State, the right of the People to keep and bear arms, shall not be infringed":

WHEREAS, The rights of the people to keep and bear arms are further protected from infringement by State and Local Governments under the Ninth and Tenth Amendments to the Constitution of the United States of America as well as Article 1 of the Constitution of the Great State of Oregon;

WHEREAS, Article 1, Section 27 of the Constitution of the Great State of Oregon states, "The people shall have the right to bear arms for the defense of themselves, and the State, but the Military shall be kept in strict subordination to the civil power";

WHEREAS, Article 1, Section 33 of the Constitution of the Great State of Oregon states, "This enumeration of rights and privileges shall not be construed to impair or deny others retained by the people";

WHEREAS, The Supreme Court of the United States of America in *District of Columbia v. Heller* upheld the individual rights to bear arms as protected by the Second Amendment of the Constitution of the United States of America. Justice Scalia's opinion stated that the Second Amendment protects an individual's right to possess a firearm unconnected with service in a militia, and to use that firearm for traditionally lawful purposes, such as self-defense within the home;

WHEREAS, Justice Thomas M. Cooley in the People v. Hurlbut 24 Mich. 44, page 108 (1871) surmises: "The State may mould local institutions according to its views of policy or expediency: but local government is matter of absolute right; and the state cannot take it away";

WHEREAS, The Fourteenth Amendment to the Constitution of the United States of America Section 1 states, "No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws";

WHEREAS, There is a right to be free from the commandeering hand of government that has been most notably recognized by the United States Supreme Court in *Printz v. United States*. The Court held: 'The Federal Government may neither issue directives requiring the States to address particular problems, nor command the States' officers, or those of their political subdivisions, to administer or enforce a federal regulatory program.";

WHEREAS, It should be self-evident from the compounding evidence that the right to keep and bear arms is a fundamental individual right that shall not be infringed and all local, state, and federal acts, laws, orders, rules or regulations regarding firearms, firearms accessories, and ammunition are a violation of the Second Amendment;

WHEREAS, Harney County asserts its legal authority to refuse to cooperate with state and federal firearm laws that violate those rights and to proclaim a Second Amendment Sanctuary for law-abiding citizens in their cities and counties;

WHEREAS, Therefore, through the enactment of this ordinance Harney County Oregon is hereby a Second Amendment Sanctuary County; NOW, THEREFORE,

THE COUNTY COURT OF HARNEY COUNTY HEREBY ORDAINS AS FOLLOWS:

SECTION 1 PROHIBITION

- 1.01 No agent, employee, or official of Harney County, a political subdivision of the State of Oregon, while acting in their official capacity, shall:
 - (a) Knowingly and willingly, participate in any way in the enforcement of any Extraterritorial Act, as defined in Section 2; or
 - (b) Utilize any county assets, county funds, or funds allocated by any entity to the county, in whole or in part, to engage in any activity that violates this ordinance by aiding in the enforcement or investigation of Extraterritorial Acts relating to personal firearms, firearm accessories, or ammunition.

SECTION 2 PENALTIES

2.01 All local, state and federal acts, laws, rules, or regulations, originating from jurisdictions outside of Harney County, which restrict or affect an individual person's general right to keep and bear arms, including firearms, firearm accessories or ammunition are, for all purposes under this ordinance defined as Extraterritorial Acts. Such Extraterritorial Acts are specifically rejected by this county, and shall not be enforced by

Harney County agents, employees, or officers and, shall be treated as if they are null, void and of no effect in Harney County Oregon.

Extraterritorial Acts for which enforcement is prohibited by Section 1 include:

- (a) Any tax, levy, fee, or stamp imposed on firearms, firearm accessories, or ammunition not common to all other goods and services on the purchase or ownership of those items by citizens; and
- (b) Any registering or tracking of firearms, firearm accessories, or ammunition; and
- (c) Any registering or tracking of the owners of firearms, firearm accessories, or ammunition; and
- (d) Any registration and background check requirements on firearms, firearm accessories, or ammunition for citizens; and
- (e) Any Extraterritorial Act forbidding the possession, ownership, or use or transfer of any type of firearm, firearm accessory, or ammunition by citizens of the legal age of eighteen and over; and
- (f) Any Extraterritorial Act ordering the confiscation of firearms, firearm accessories, or ammunition from citizens; and
- (g) Any prohibitions, regulations, and/or use restrictions related to ownership of non-fully automatic firearms, including but not limited to semi-automatic firearms; including semi-automatic firearms that have the appearance or features similar to fully automatic firearms and/or military "assault-style" firearms by citizens; and
- (h) Any prohibition, regulations, and/or use restrictions limiting hand grips, stocks, flash suppressors, bayonet mounts, magazine capacity, clip capacity, internal capacity, or types of ammunition available for sale, possession or use by citizens; and
- (i) Any restrictions prohibiting the possession of open carry or concealed carry, or the transport of lawfully acquired firearms or ammunition by adult citizens or minors supervised by adults.
- 2.02 Any agent, employee or official of Harney County Oregon accused to be in violation of this ordinance may be made a defendant in a civil proceeding pursuant to ORS 203.065.
- Fines recovered under ORS 203.030 to 203.075 shall be paid to the clerk of the court in which recovery is had. After first deducting court costs in the proceedings, the clerk shall pay the remainder to the treasurer of the county for the general fund of the county, pursuant to ORS 203.065.

- 2.04 A violation of this ordinance is a Class A violation, per ORS 203.065, with a maximum fine of \$2,000 for an individual, and \$4,000 for a corporation, per ORS 153.018.
- 2.05 Any peace officer, as defined by ORS 161.015, may enforce this ordinance, adopted under ORS 203.035.

2.06 Exceptions to Section 1:

- (a) The protections provided in Harney County by Section 1.01 of this ordinance do not apply to persons who have been convicted of felony crimes.
- (b) This ordinance is not intended to prohibit or affect in any way the prosecution of any crime for which the use of, or possession of, a firearm is an aggravating factor or enhancement to an otherwise independent crime.
- (c) This ordinance does not permit or otherwise allow the possession of firearms in State or Federal buildings or courthouses.
- (d) This ordinance does not prohibit Harney County, its employees, officials and agents from enforcing local, federal or state firearms acts, laws, rules or regulations in effect as of February 1, 2021.
- (e) Actions in compliance with a court judgment or court order, based upon any Extraterritorial Act in effect as of February 1, 2021, are exempt from this ordinance.
- (f) This ordinance does not prohibit Harney County from enacting any other legislation to govern its own residents, and exclusively and only applies to county officials, employees and agents whose role and duties are primarily if not wholly a county concern.
- (g) This ordinance does not apply to, nor prohibit, the enforcement of local firearms regulations which have been enacted by the voters of Harney County.
- (h) This ordinance does not apply to, nor prohibit, enforcement of firearms regulations as of February 1, 2021 pursuant to the directives of, written administrative decisions, or written policies of the County Sheriff or the District Attorney, and the Sheriff and District Attorney retain all prosecutorial, enforcement, or administrative discretion and authority that the Sheriff or District Attorney would otherwise have under federal, state, or local laws after February 1, 2021 so long as said discretion and authority is exercised consistent with the legislative directives of this ordinance.

SECTION 3 PRIVATE CAUSE OF ACTION

- 3.01 Any official, agent, or employee of Harney County who knowingly violates this ordinance shall be liable to the injured party in an action at law, suit in equity, or otherproper proceeding for redress.
- 3.02 In such actions, the court shall award the prevailing party, other than the government of Harney County Oregon or any political subdivision of the county, reasonable attorney fees and costs.
- 3.03 Neither sovereign nor governmental immunity shall be an affirmative defense of agent, employee or official of Harney County in cases pursuant to Section 2 or 3 of this ordinance.

<u>SECTION 4</u> SEVERABILITY

SECTION 5

4.01 The provisions of this ordinance are hereby declared to be severable, and if any provision of this ordinance or the application of such provision to any person or circumstance is declared invalid for any reason, such declaration shall not affect the validity of the remaining portions of this ordinance.
